**2. RESOLUTION AUTHORIZING THE SUPERVISOR TO EXECUTE AND DELIVER AN AGREEMENT BETWEEN THE TOWN OF EASTCHESTER AND PANGO, A MOBILE PAYMENT SERVICE FOR PAYMENT OF VEHICLE PARKING ON TOWN OWNED AND OPERATED PARKING SPACE**

Supervisor Colavita announced the town will partner with Pango to offer a pay by phone option at parking meters. He explained it's easy to setup an account; simply download the parking app on your smartphone, enter the vehicle(s) and credit card information – one time only. Whenever parking in Eastchester, simply open the app, choose your vehicle, enter the parking meter number, select the amount of time you want to park, hit start and you have paid the fee via Pango. The program has been used successfully in the Village of Bronxville for several months and has recently been introduced in the Village of Tuckahoe.

Councilman Bellitto offered a motion that was seconded by Councilman Marcoccia to approve a RESOLUTION authorizing the Supervisor to execute and deliver an agreement between the Town of Eastchester and Pango, a mobile payment service for payment of vehicle parking on Town owned and operated parking spaces.

Supervisor Colavita offered a motion that was seconded by Councilman Dooley to approve a RESOLUTION authorizing the Supervisor to sign the Agreement with Westchester County Department of Senior Programs and Services for WIN, in the amount of \$37,914 & NSIP, in the amount of \$13,250, including Schedule A, Schedule B and Schedule C.

The funding is designated for the home delivered meal nutrition services provided to senior citizens.

**IX. COUNCIL MEMBER REPORTS**

In response to Supervisor Colavita’s challenge to support Relay For Life ’18; Councilman Bellitto pledged \$750, Councilman Dooley, Councilman Marcoccia and Town Clerk Linda Laird each pledged \$500 and Councilwoman Nicholson stated she would continue to raise funds for the event via the team she has raised money with for many years. All commended the Supervisor for his commitment to this important cause.

Councilman Marcoccia reported on the July 12<sup>th</sup> Library Board Meeting at which the board discussed the 2018 Library Budget and on the Summer Reading Game for children entering Grades K - 5 and reading independently. Mr. Marcoccia announced the teen pool parties scheduled for July 25th, August 1st, and August 15th are for Teen Scene Members and Lake Isle Members between the ages of 12 and 17. Additionally, the adult pool will be open for 'late night swim' on Fridays from 8pm-10pm.

Councilman Bellitto reported the 'speed signs' that read and display the speed at which an approaching car is traveling have been placed throughout town and are having the intended effect of educating drivers and slowing down traffic in town.

Councilman Dooley announced the Eastchester Historical Society Fall Fundraiser will be held on Friday, September 2nd at 6pm and will feature Charles Wissinger as the Marquis de Lafayette.

Councilwoman Nicholson announced the Eastchester Environmental Committee's *Green Day* event will be held on Saturday, September 16<sup>th</sup>, on the grounds of Town Hall.

Supervisor Colavita reported that while there were no elevated levels of TCE's reported during continued air testing near the Marbledale Road project; the NYS DEC and Westchester County Department of Health continue their efforts to determine the source that triggered the higher than normal readings in February.

The Supervisor announced Moody's maintains a Aaa rating on the town's outstanding parity debt. The Aaa rating reflects the town's healthy reserves and liquidity, combined with a stable tax base, very low debt burden, and elevated pension burden.

**X. SECOND OPPORTUNITY TO ADDRESS THE BOARD**

Charles Wieseahn spoke about the poor condition of the blacktop at the Leewood Tennis Court. The Supervisor stated the Town tried to make the court a playable surface by filling in the cracks, and the Town is contemplating and examining the reconstruction of brand new courts at either the Leewood Park or at another location in town.

There being no further public comment, the meeting was adjourned at 8:45 p.m.
