IV. OPPORTUNITY TO ADDRESS THE BOARD ON AGENDA ITEMS

David Levy spoke in opposition to the Settlement of a Certiorari Proceeding by Consolidated Edison Company (Law Agenda, Item 1) stating Consolidated Edison (Con Ed) continues to raise the price of electricity and delivery to the residents of Eastchester should not be entitled to an assessment reduction. The Supervisor responded by stating that while Mr. Levy makes many valid points regarding proposed rated increases by Con Ed, the venue for that testimony is before the Public Service Commission.

Mike Denning asked for an explanation of the way in which Con Edison' infrastructure is assessed. Supervisor Colavita suggested the Town Board table the Law Agenda Item 1, involving the settlement of a certiorari proceeding by Con Ed to allow an opportunity for Town Assessor Todd Huttunen to provide an explanation to the Town Board and public.

IX. **COUNCIL MEMBER REPORTS**

Councilman Marcoccia announced the opening of, *The Snack Shack*, a full service bar and café on the balcony of the golf pro shop. The café is open to both Lake Isle members and the public, Thursday – Sunday's, from 11a.m. to 7 p.m. Live entertainment will be on-hand each Saturday at 4 p.m.

Councilman Bellitto welcomed several Bronxville High School students in the audience and extended congratulations to organizers of the Eastchester/ Tuckahoe Memorial Day Ceremony. Due to rain, the last minute transition into the Eastchester High School auditorium appeared effortless, and the commemoration continued on schedule.

Councilman Dooley announced the Eastchester Beautification Foundation's Annual Meeting will be held on June 13th at 7:00 pm in the Library. Mr. Dooley encouraged the public to support the organization and their efforts by joining via their website, www.ebfgrows.org.

Councilwoman Nicholson announced that while the Recreation Department is gearing up for the various summer camps; auditions for the Summer Theater production of *Grease* are being held for members of the cast and crew.

In closing, Mrs. Nicholson announced the annual Eastchester Green Day is scheduled for Saturday, June 11th at Town Hall between 10am and 1pm.

Supervisor Colavita announced the opening of the Eastchester Public Library Courtyard. The outdoor area will be used for Library programs, reading and relaxing by patrons and the public. The wheelchair accessible Courtyard was constructed on the north side of the building in an area that adjoins the parking lot. The Supervisor thanked JMA

Landscaping Inc., Nick's Electric, Globe Fence and Railing, Inc., Paladino Concrete Creations Corp. and A & J Sprinkler Systems, Inc. who were the contractors for the job outside of Town personnel. The courtyard also contains three plum trees which will be dedicated to Fred Moses, Jack and Ina Polak and Stefan and Anna Weinberg.

In closing, Supervisor Colavita announced the street paving project will continue through to the end of June.

X. SECOND OPPORTUNITY TO ADDRESS THE BOARD

David Levy congratulated Sally Veltidi, Superintendent of Recreation, on her election to the Eastchester Union Free School District. Further, Mr. Levy suggested renovations are needed at Saggese Field and stated the Fire District has not met their financial obligation to the NYS Pension System.

In closing, Mr. Levy referenced a decision made by the Commission on Judicial Conduct that admonished Judge Calano for misconduct for 'delegating her judicial duties.' The commission said that Judge Calano allowed the Deputy Town Attorney to negotiate pleas with defendants for vehicle and traffic cases. Mr. Levy stated Judge Calano is "fair" and "good for the community."

Mike Denning reported finding syringes in the gutter and sewer near his home and expressed concern over the growing use heroin in our culture and the recent increase of overdoses.

There being no further public business, the meeting was adjourned at 9:25 pm.
