SEASONAL MEMBERSHIP DETAILS

General Information

- Application Forms a separate application form must be completed for each membership desired. Please call the Lake Isle Office at (914) 961 3453 ext. 1 for additional forms.
- Sex, Age, and Date of Birth must be entered for all children to be included on family and junior memberships, and those included on child care worker permits.
- Children under age 2 need not be considered when selecting a membership, they may accompany their parent(s) or legal guardian(s) to the pool without fee, however, name, sex, age, and date of birth must be entered as with other children.
- Children under age 14 are subject to some accompaniment requirements and use restrictions.
- Photo/ID Card all persons to be included for seasonal membership use must be photographed with the exception of children under age two. Photo/ID cards must be picked up at the Office.
- · Locker Rental locker rental is optional; however, locker room use is available only if option has been selected.
- Holidays are those days as celebrated by the Town of Eastchester.

Seasonal Membership Descriptions

- Comprehensive memberships include golf, pool, and tennis use. Pool & Tennis memberships include both pool and tennis use. All other memberships are designated as for Golf only, Pool only, and Tennis only.
- Any Tennis membership on this application is for the <u>outdoor season</u> only.
- Family means applicant, applicant's spouse, and/or applicant's unmarried children under age 24 residing with applicant.
- Individual means any person age 14 or over.
- Child Care Worker (including au pair) allows individual pool complex admission and pool use ONLY when accompanied by the child(ren) of the specific family signing Child Care Worker application. ONLY ONE MEMBERSHIP PER FAMILY; minimum age of child care worker is 17. Verification of working relationship must be provided.
- Individual Weekday Golf allows golfing on weekdays only (excluding holidays and when golf outings are scheduled on Mondays).
- Senior Citizen Memberships for persons age 62 years and over only; available for Individual Daily Golf, Individual Weekday Golf, and Individual Tennis Memberships.
